Application fee	<ul style="list-style-type: none"> ✧ HK\$30- (to be collected together with the application form). The application fee is non-returnable whether the application is successful or not.
Application for the "2026/27 Registration Certificate for Kindergarten Admission"	<ul style="list-style-type: none"> ✧ The Government implemented the "Kindergarten Education Scheme". Under the Scheme, EDB will use the "Registration Certificate for Kindergarten Admission" as the document for registration in the 2026/27 school year. ✧ If parents wish to apply for admission to a K1 class in a Scheme-KG for their children in the 2026/27 school year, they are required to apply to the EDB for the Registration Certificate for KG Admission (hereafter referred to as "RC") from September to November 2025. If a child cannot obtain an RC as he/she can receive education in Hong Kong but is not eligible for subsidy under the Scheme, the EDB will issue a Kindergarten Admission Pass (hereafter referred to as AP) to the child concerned for registration to a Scheme-KG, but the parents concerned are required to pay full school fees (i.e. before deduction of subsidy under the Scheme) as shown on the Fees Certificate of the KG admitting the child. ✧ The "RC" will be open for applications in September 2025 and EDB will announce and upload the details of application onto EDB's website https://www.edb.gov.hk/en/edu-system/preprimary-kindergarten/kindeergarten-k1-admission-arrangements/2627_admission_arrangements.h tml
Admission Criteria	<ul style="list-style-type: none"> ✧ Interview performance. ✧ The applicant with sibling(s) currently studying in the kindergarten will be given due priority consideration.

Interview Arrangements	<ul style="list-style-type: none"> ✧ The kindergarten will arrange interview for all applicants. ✧ Interviews will be conducted from November, 2025. ✧ All children will have individual interview. Only one parent is allowed to accompany with the child to participate in the interview.
Announcement of Admission Results	<ul style="list-style-type: none"> ✧ We will inform parents about the K1 admission results before 12 December 2025 by post.
Registration Arrangements	<ul style="list-style-type: none"> ✧ Successful applicants: Parents should complete the registration procedures for their child from 8 to 10 January 2026 (“Centralised Registration Dates”) by submitting the e-RC / AP to the kindergarten and paying the registration fee (HK\$600.-). ✧ Applicants on the waiting list: School will inform parents about the date of registration by post and phone call. Parents should complete the registration procedures for their child according to the specified date set by the school. ✧ Please be reminded that if parents cannot submit the e-RC / AP during registration, the kindergarten may not be able to complete registration for their child. ✧ If a child is admitted after the Centralised Registration Dates, parent is still required to submit the e-RC/AP for registration. ✧ If parents decide to change school after registration, please notify the kindergarten in writing. Parent is required to complete the de-registration with the KG with which he/she has registered by scanning the QR code on the e-RC/AP. Upon de-registration, the KG concerned will no longer reserve the place for the child. Normally, the registration fee paid to the KG with which the parent has registered will not be refunded.
